This is regarding Pre-qualifiers submitted by S.A. Engineering College, Poonamallee- Avadi, Road, Veeraraghavapuram, Thiruverkadu(PO), Chennai- 600 077, Tamil Nadu for the UG Mechanical Engineering program in whose case the period of accreditation in Tier II has expired on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II in January, 2013 document initially for a period of 3 years upto 30/06/2017, then were further accredited for a period of 3 years upto 30/06/2020 on the basis of Compliance Report, and were granted accreditation for the Academic Year 2020-21 i.e. up-to 30/06/2021 on the basis of Compliance Report submitted by the Institute due to Covid-19 pandemic situation, the programs will be considered for accreditation of one year for the Academic Year 2021-22 on the basis of the programs meeting the pre-qualifiers. 

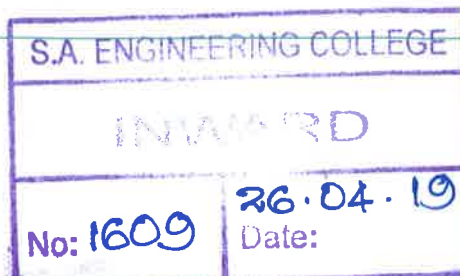
