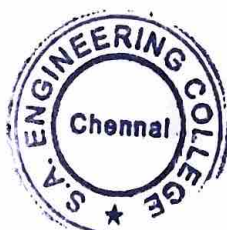
Subject: Reconstitution of Student Grievance Redressal Committee for the Academic Year 2025-2026.

Functions of the Student Grievance Redressal Committee (SGRC):

- Complaints raised by students shall be addressed to the Chairperson of SGRC.
- The SGRC shall follow principles of natural justice while considering any grievance.
- The committee shall submit a report with recommendations to the Institution within 15 working days from the receipt of a complaint.
- A copy of the report shall be forwarded to the aggrieved student.
- If dissatisfied, the student may appeal to the Anna University Nominee within 15 days from the date of the SGRC decision
